# 2009 KAHSA WEB-ED CLUB

The KAHSA WEB-ED Club is a system of online education that is a convenient and economical way to bring quality professional development right to you! All you need to participate is a computer with Internet access and a speaker phone. You can have as many staff members in attendance at each webinar that you wish, and the price includes administrator or nursing CEUs for up to 6 people!

How it works:

Each webinar is priced at \$119 individually, but as Club members, you pay only \$89 for each session. To join, you will agree to purchase at least six webinars up front. ( 6 @ \$89 = \$ 534) You will be sent the information on each webinar in advance via email, and you will register for each webinar using the link provided to you in the email. After registration you will receive information about how to get your continuing education hours.
